## **Resolution 2024-28**

## An Emergency Resolution to amend Resolution 2024-14 sewage treatment system fee schedule and re-establish the household abandonment fee March 7, 2024

- The Board of Health of Huron County Public Health, Huron County, Ohio met at a regular meeting of the Board, on March 7, 2024 at 1:00 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:
- **WHEREAS**, the Board of Health of Huron County Public Health, discovered a sewage fee that exceeds the amount allowed per 3701-29 of the Ohio Administrative Code; and
- **WHEREAS**, the Board of Health of Huron County Public Health is reducing the household abandonment fee to \$333.24 per OAC 3701-36-14; and
- WHEREAS, Huron County Public Health is requesting a motion to temporarily suspend the normal three readings in order to amend the District household abandonment fee established in Resolution 2024-14 for the Sewage Treatment System program pursuant to 3709.09 (C) as an emergency measure:
- NOW THEREFORE BE IT RESOLVED, the Huron County Board of Health amends the household abandonment permit fee in Section I pursuant to 3709.09 (C) as an emergency measure. The Board's decision to use emergency legislation is based on a requirement within the law that is being implemented while maintaining the immediate preservation of the public's peace, health, and safety within the Huron County Public Health District.
- **BE IT FURTHER RESOLVED,** the District portion of the new fees shall go into effect on March 7, 2024 and will be subsequently evaluated and voted upon again after three readings and a public hearing. An electronic copy of Resolution 2024-28 will be maintained at the District's office for proper record keeping and reporting purposes.
