RESOLUTION 2024-93 A resolution to adopt and validate the amended service fee and license charges schedule for the Implementation and Administration of the Food Service Operation and Retail Food Establishment Rules January 9th, 2025

The Board of Health of Huron County Public Health, Huron County, Ohio met at a regular meeting of the Board, on November 7th, 2024 at 1:00 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, the Board of Health of Huron County Public Health has completed a cost methodology in compliance with Chapters 3701-21 and 901:3 of the Ohio Administrative Code; and

WHEREAS, the Board of Health of Huron County Public Health, to properly implement and administer 3701-21, 3717-1, and 907:3-4 of the Ohio Administrative Code, repeals the District portion of the service fee and license charges schedule established in Resolutions 2023-66, 2024-13, 2024-15, 2024-68; and

NOW THEREFORE BE IT RESOLVED, the service fees and license charges have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below. An electronic copy of Resolution 2024-85 will be maintained at the District's office for proper record keeping and reporting purposes.
