- **WHEREAS**, the Board of Health of Huron County Public Health, to properly implement and administer 3701-21, 3717-1, and 907:3-4 of the Ohio Administrative Code, repeals the District portion of the service fee and license charges schedule established in Resolutions 2023-66, 2024-13, 2024-15, 2024-68; and
- **NOW THEREFORE BE IT RESOLVED**, the service fees and license charges have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below. An electronic copy of Resolution 2024-85 will be maintained at the District's office for proper record keeping and reporting purposes.
