WHEREAS, the Board of Health of Huron County Public Health, to properly implement and administer 3701-09 of the Ohio Administrative Code, repeals the District portion of the service fee, permit, and fine schedule established in Resolutions 2023-70, 2023-107, 2024-14, 2024-28, 2024-30, 2024-68; and

NOW THEREFORE BE IT RESOLVED, the service fees, permits, and fine schedules have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below.
